Vaccine Mandate Guidance for Post-Secondary Students, Staff, and Faculty from Children's Health Defense Canada

Thank you very much for your email. Children's Health Defense Canada (https://children-shealthdefense.ca) is receiving many emails from many post-secondary students, faculty, staff and parents. The situation is rapidly changing. For your reference, below is a list of Frequently Asked Questions that we hope will help you. For those who would like to become a plaintiff in the case, please see the information at the end.

FREQUENTLY ASKED QUESTIONS

I am a post-secondary student. What are my options?

At this time, there are three basic options for students affected by the post-secondary Covid injection and testing mandates recently implemented at most Ontario Universities and Colleges:

Option 1. Submit either a medical exemption or a Religious/Creed exemption. You will obtain your institution's version of the exemption form, complete it, have it notarized by a Commissioner of Oaths (this can be done at your City Hall), and scan it back to your institution.

**PLEASE NOTE: This option waives your right to take legal action against your school through the action being taken by Children's Health Defense Canada and the Constitutional Rights Centre. As well, if you submit an exemption, you must understand that you may be mandated to take some form of the CV test twice per week, due to revealing that you have not taken the injections.

There is no guarantee that your exemption will be accepted, and now you are identified. They can revoke the exemption at any time. PCR testing has high false positive rates. By signing the exemption form, you are agreeing their policies are lawful.

Option 2. Change all course delivery to online/virtual learning.

Option 3. Defer the study year.

If you choose Option 2 or 3, joining our legal action remains an option.

Can Children's Health Defense Canada help me with completing exemption forms?

No, under no circumstance.

Children's Health Defense Canada is working closely with the Constitutional Rights Centre to take legal action against the post-secondary institutions that have implemented Covid-19 injection mandates. Students or Faculty/Staff members who submit exemption forms will waive their rights to take legal action against their institutions. As a result, CHDC will not be taking part in any exemption process. These vaccine policies are illegal, unconstitutional, and even criminal, and therefore we will not partake or be complicit in advancing this unconstitutional behavior by participating in these exemptions.

Who can be a plaintiff?

Only students, faculty, or staff members of the post-secondary institution may be plaintiffs in our legal action. Parents cannot be plaintiffs unless their child is under age 18. In this case, they would be litigation guardians for their child.

What is entailed with being a plaintiff?

The deadline to submit your intent to become a plaintiff is **Sunday, August 29, 2021**. Since CHD is receiving many inquiries, they are asking that only the student or faculty/staff member reply to them and that they send an email to childrenshealthdefenseON@protonmail.com with the subject line "PLAINTIFF CONFIRMATION."
